Thanks to the staff: A big Plus for Peters

Kempen, 5 Jan 22 – Good Lack! Peters starts the new year with a cheerful greeting and is positive for 2022 when viewing the annual balance sheet 2021. "This has been a good year for us: Despite the pandemic, turnover has increased by approx. 30 percent", says Ralf Schwartz, CEO of Lackwerke Peters GmbH & Co. KG. The giant economical leap forward of the last few months is connected to the remarkable development of the ELPEGUARD® conformal coating business. "In particular with our Twin Cure® UV types, we have succeeded in entering megatrend technologies on a large scale also in China," reports Schwartz. This applies both to the production of battery controllers for e-mobility and to assemblies for converters that are necessary for the conversion of electricity from new energy sources.

In Europe, Peters' Elpemer solder masks have fortified the top market positions in Germany, Italy, and Switzerland and also in some neighbouring Eastern European countries. "We had a good business start with Unimicron Germany and were also able to acquire many Italian PCB manufacturers," reports the CEO. According to Schwartz, well-known OEMs list Elpemer® in their approval lists. In this context, Peters still sees room for improvement among PCB suppliers in Asia.

From the Peters' portfolio, the ELPECAST® casting compound business has also experienced a positive development in 2021, above all in Germany and in adjacent European countries.

Ralf Schwartz sees the flexibility and motivation of his employees as main factor for the rising business curve in spite of the most difficult pandemic situation. "We thus managed the transfer into Corona-related mobile working and the worldwide digital communication very well." This common thread of commitment, motivation and team orientation is evident for all 160 active employees of the worldwide Peters Group, and of course also in the headquarters in Kempen, Germany, where about 130 staff members are working. "The Kempen location shall remain the center of our business also in the future", underlines the CEO of the familyowned company whose primary objective besides proximity to customers is to secure workplaces.
